FOSTER HOME CONTRACT

PittieLove Rescue, Inc. is an all volunteer, non-profit 501c3 rescue organization dedicated to helping homeless American Pit Bull terriers and pit bull mixes. PittieLove Rescue does not have a shelter and relies on foster homes to provide temporary housing for rescued dogs until a permanent home is found.

PittieLove Rescue will pay all necessary veterinary expenses. All veterinary care, except emergencies, must be pre-approved by Noreen Ford/PittieLove Rescue.

Foster homes are eligible to adopt their foster dog or any other available dog in the rescue program. The standard adoption donation will be required and the foster caregiver will be required to fill out an adoption contract.

1. I/we agree that the dog will not be used for any illegal purposes.
2. I/we hereby agree to care for this dog humanely (including providing adequate food, water, shelter, love and attention.) Said dog shall be maintained in an adequate enclosed area or on a leash at all times. Dog shall not be allowed to roam at will. If Said becomes lost or stolen, I/we agree to notify Noreen Ford/PittieLove Rescue immediately.
3. I/we agree that said foster dog is not to be left with small children at any time when unattended by a responsible adult.
4. I/we agree that said foster dog will be kept under the control of a responsible adult at all times when in a public place.
5. I/we agree that said foster dog will not be allowed to run off leash at public parks. I further agree not take my PittieLove foster dog to a "dog park" or "doggie day care"
6. I/we agree to notify Noreen Ford/ PittieLove Rescue of any change of address or phone number.
7. I/we agree to return the dog to PittieLove Rescue if I/we no longer wish to foster it. I understand that we must be flexible as another foster home may not be immediately available.
8. I/we agree not to leave our foster dog enclosed in a cage or building unattended for long periods of time

9. I/we agree not to leave our foster dog unattended when outside even if the dog is in a fenced yard. I realize that unattended dogs, especially pit bulls, are often the target of thieves or abusive people.

10. I/we agree to notify Noreen Ford/PittieLove Rescue if we observe any physical or health problems with our foster dog.

11. I/we agree to notify Noreen Ford/PittieLove Rescue immediately if we observe any behavior problems with our foster dog.

12. I/we understand that a dog's behavior may change when the dog is placed in a new environment and after the dog accustoms itself to a new home.

I/we accept responsibility for the PittieLove foster dog placed in my care and hereby release and hold harmless PittieLove Rescue, Inc. forever from liability for any injury, illness or damages to the foster caregiver or his/her property caused in the future by the foster dog and from any causes of action, claims, suits or demands that may arise as a result of such injury or damages.

TERMS OF SURRENDER:

I/we the undersigned, hereby IRREVOCABLY surrender to Pittielove Rescue, Inc. for placement and adoption,
A Pit Bull described as follows:

1. REPRESENTATIONS AND WARRANTIES – We hereby represent and warrant to Pittielove Rescue, Inc their agents, successors and assigns that the undersigned is/was in custody of the above described Pit Bull. That I/we have full power and authority to surrender this animal for adoption.
2. PERTINENT INFORMATION – We agree to provide Pittielove Rescue, Inc. with any documents and all other available information concerning this Pit Bull which might assist in matching this Pit Bull with the proper prospective adoptive home, including health and shot records and information concerning this Pit Bull's history.
3. SURRENDER OF RIGHTS - By executing this document, we understand that we are giving up forever all right, title and interest to the above-mentioned Pit Bull and we further understand that all future decisions regarding this animal will be made solely by Pittielove Rescue, Inc. We also understand that if this Pit Bull is later found to have such an unpredictable temperament as to be unsuitable for any placement, or if the animals' quality of life is substantially impaired, in the opinion of a competent veterinarian, by a chronic, irreversible, painful condition, euthanasia may be considered as a final alternative to adoptive placement.
4. I/we, the undersigned, hereby specifically and forever release, and hold Pittielove Rescue, Inc. harmless, from any and all liability arising from the placement for adoption by Pittielove Rescue, Inc., of the above-mentioned Pit Bull, or for any other actions taken by Pittielove Rescue, Inc. in accordance with, and reliance on, the representations we have made, and the authorization we have provided under the terms of this document. We agree to indemnify and hold harmless Pittielove Rescue, Inc. for any damages suffered and expenses incurred (including legal fees) in defending any legal action, whether for bodily injuries or death, property damage, breach of contract, or otherwise, whether instituted by us or by any other person or persons including the adoptive owners, arising out of or in consequence of the placement of the Pit Bull, in reliance on the authorizations, representations and warranties we have made in this agreement.
5. I/we certify that this dog is not possessed of any dangerous or vicious propensities, and that I/we have not willfully concealed information about the dog that might indicate such propensities.

3. I agree to obtain the services of a veterinarian for this animal for examinations and immunizations as needed; and to procure immediate veterinary care, at my own expense, should the animal become ill or injured.
4. If at any time, for any reason, I decide not to keep the animal, I agree to contact the MSPCA.
5. I agree that all health and/or behavioral information regarding this animal that the MSPCA is reasonably aware of have been discussed with me by an adoption counselor and all available information has been documented and provided to me. I understand that the MSPCA makes no representations with regard to this animal's health, temperament, or other condition.
6. Many animals are received by MSPCA adoption centers as "strays." On very rare occasions, a person may provide evidence that he/she is the rightful owner of this animal after the animal has been placed in a new home. I understand that should this situation arise, I may be contacted by the MSPCA to discuss the possibility of returning the animal I adopted.
7. I understand that the animal I am adopting has already been sterilized.
